TRIP/ACTIVITY AND WAIVER INFORMATION:

A. I understand that I do not hold a reserved place on any trip until the required first full deposit of fifty dollars (\$50) has been paid to the Clear Lake Area Ski Club, Inc. (CLASC). Further:

Delinquent payments in excess of ten (10) days are grounds for cancellation by the trip leader and that in such cases cancellation penalties will apply, as described in Section B below.

Incremental payments may be made toward required deposits if arranged with the trip leader in advance in writing. Incremental payments must be made in such a manner that they total the full amount due on the specified deposit due date.

B. I understand that if I cancel or fail to meet the required deposit schedule after the full first deposit is made, I will incur a twenty-five dollar (\$25) per person cancellation fee and all **other** payments will be refundable or partially refundable subject to the following conditions:

If I can be replaced by the Trip Leader from the waiting list.

If no replacements can be found from the waiting list, I have the option of finding a replacement for myself.

Whatever fees the Trip Leader/CLASC is able to recover from the resort, lodging, airline, bus company, or other agencies through which this trip may be booked. I understand that it is my responsibility to ascertain if any tickets booked for me are non-refundable.

C. I hereby appoint the Clear Lake Area Ski Club, Inc. (CLASC), its officers, and trip leaders as my agent to perform all acts and to enter into any and all contracts as may be deemed desirable in connection with any ski trip or other CLASC activity. I understand that CLASC acts only as coordinator and accepts no responsibility for the services of any person, ski area, airline, motor coach, hotel, or any organization whatsoever rendering any of the services or accommodations being offered on any trip. Ski trip and other activity fees are based upon current tariffs and are subject to change without notice. CLASC accepts no responsibility in whole or in part for any delays, delayed departure or arrival, missed airplane or other carrier connections, loss, damage, or injury to person or property, mechanical defect or failure of any nature howsoever caused, or for any substitution of hotels or of common carrier, with or without notice, or for any additional expenses occasioned thereby. I fully understand that CLASC is a voluntary association run by volunteers who have no special training in conducting ski trips or other activities. By participating, I do not rely on the expertise of any director, officer, activity coordinator, or the agents of any of the foregoing. I acknowledge that there are inherent risks and dangers involved in skiing and other activities, and I agree that I am solely responsible for my personal safety and conduct and for meeting all payment deadlines. Should I miss my departure, I understand that I may not be able to recover any part of my trip or activity payment. I agree to indemnify and hold harmless CLASC, its directors, officers, and trip leaders, or coordinators from any loss, cost or expense incurred by or attributable in any way to me in connection with any ski trip or other activity. I agree to abide by the Bylaws, rules and regulations of CLASC and the rulings of Trip and Activity Coordinators in connection with any ski trip or other activity.

By applying for membership in CLASC, I hereby certify that I have read, that I understand, and that I agree to the acceptance of the cancellation and release liability statements above. This acceptance also applies to all members listed on this application that are less than 18 years old.
